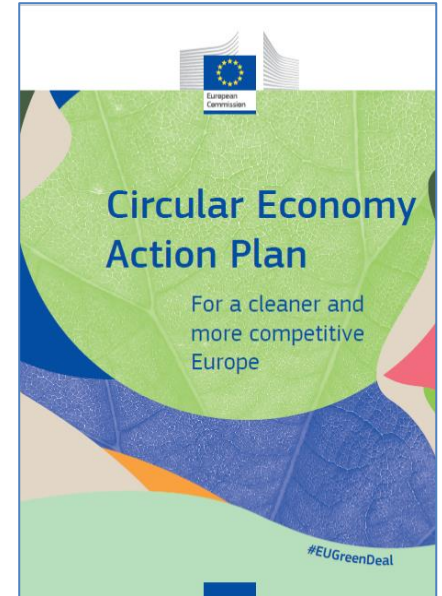

Connecting economic & environmental gains



EU strategy for sustainable and circular textiles

Aim.- Create a **greener, more competitive sector** that is more resistant to global shocks

Commission's 2030 Vision for Textiles.-

- **all textile products placed on the EU market** are durable, repairable and recyclable, to a great extent made of recycled fibres, free of hazardous substances, produced in respect of social rights and the environment
- **“fast fashion is out of fashion”** and consumers benefit longer from high quality affordable textiles
- profitable **re-use and repair services** widely available
- the **textiles sector is competitive, resilient and innovative** with producers taking responsibility for their products along the value chain **with sufficient capacities for recycling and minimal incineration and landfilling**



Zero Pollution Action Plan → Zero pollution for 2050

Key 2030 targets.-

- improving **air quality** to reduce the number of premature deaths caused by air pollution by 55%;
- improving **water quality** by reducing waste, plastic litter at sea (by 50%) and microplastics released into the environment (by 30%);
- improving **soil quality** by reducing nutrient losses and chemical pesticides' use by 50%;
- reducing by 25% the EU ecosystems where **air pollution** threatens biodiversity;
- reducing the share of people chronically disturbed by **transport noise** by 30%, and
- significantly reducing **waste generation** and by 50% residual municipal waste

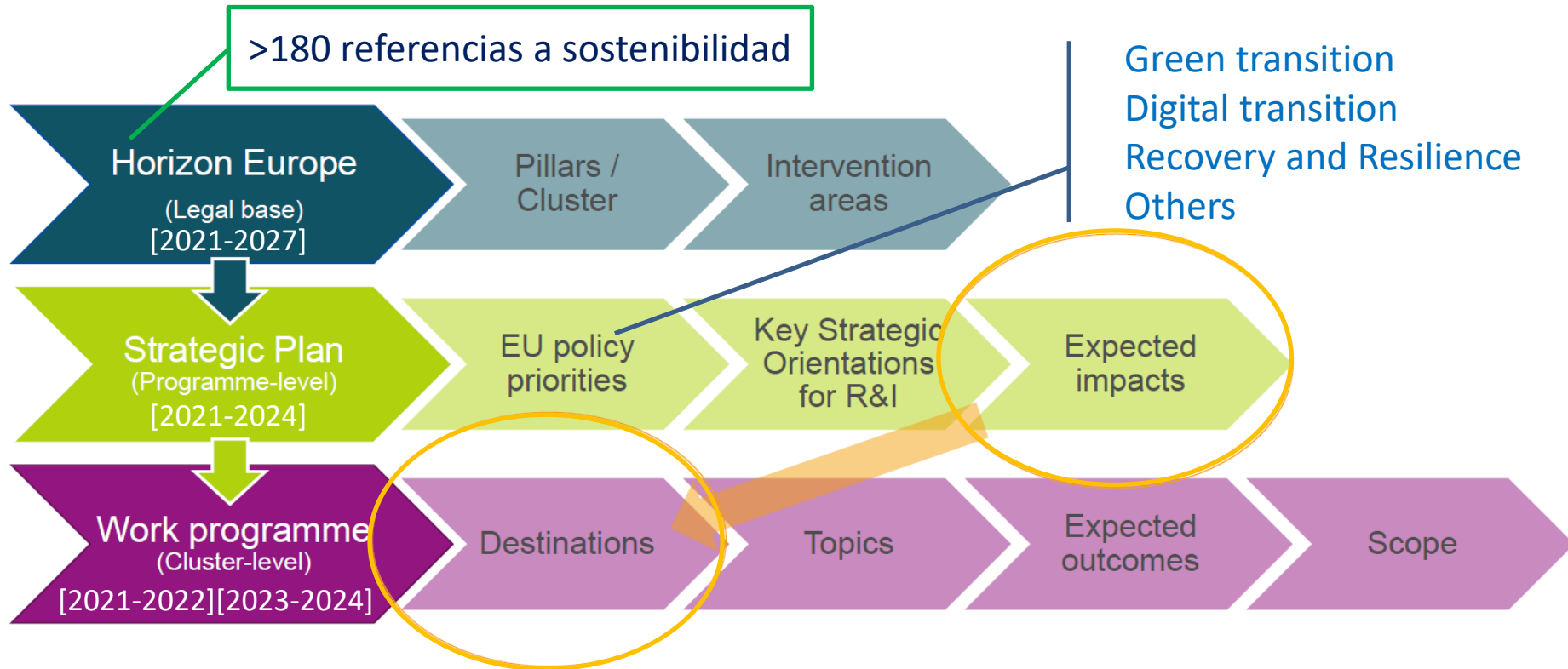
Important information

- SSbD is an **R&I approach** to promote use of the latest scientific knowledge, **harmonize assessments** and to meet ambitious levels for **safety and sustainability in innovation**.
- SSbD is **voluntary** and promoted **within R&I actions** across EU research programmes, especially Horizon Europe. Member States, industry, academia and RTOs are invited to promote the use of SSbD in innovation.
- **SSbD is neither a regulation, nor mandatory**

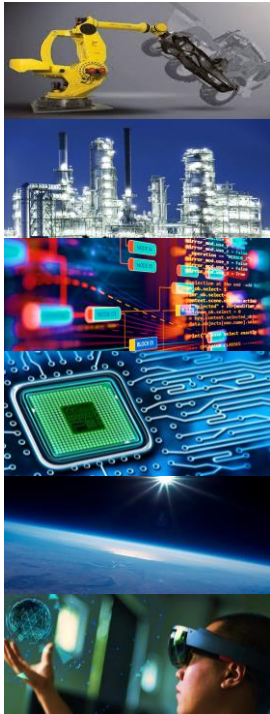
